### Form Completion Instructions:

1. You must submit a separate Competitor Registration Form for each competitor, so please make the necessary copies of this form before you begin.
2. Please complete all fields of information using a **typewriter or legible handwriting**.
3. As a reminder, both the competitor (see page 3) and instructor (see page 5) must sign this form before it is submitted. **Please Note: Electrical competitors must sign the form a second time (see page 4), indicating they are aware of the electrical competition in which they are registered.**

### Important Information:

- This form should be completed by a representative of the competitor's sponsor, defined as the chapter, member firm or chapter-approved training program sponsoring the competitor to attend the National Craft Championships.
- **There is no fee due for this portion of the 2012 competitor registration process. When you submitted the required Intent to Compete Form with the \$225 payment by February 3, you completed all payment obligations to ABC National for your competitor.**
- You must complete this entire form for each competitor, including:
  1. Competitor Information
  2. Statement of Eligibility, Guidebook Acknowledgment and Release of Claims (competitor signature required)
  3. Competitor's Sponsor Information
  4. Employer Information (if different than competitor's sponsor)
  5. Electrical Competition Acknowledgment (competitor signature required) – **For Electrical Competitors Only**
  6. Tool Certification (instructor signature required)
- Be sure to **ACCURATELY and LEGIBLY** fill in the **Competitor's Name** and the **Competitor's Employer** so that we can properly recognize the competitor and his/her employer at the awards ceremony and in event publications.
- Although it is the National Craft Championships Committee's intention to conduct all advertised competitions, a craft skills competition may be cancelled if a competition's participation falls to only one competitor after the Competitor Registration deadline. In this case, the National Craft Championships Coordinator would notify the competitor's sponsor immediately to reach a mutually agreed upon resolution, taking into consideration several factors, including the sponsor's financial investment up to that point.
- Please submit this form as soon as possible but **no later than the deadline of March 5, 2012**. In addition, all **Competitor Guest Registration Forms are due no later than March 5, 2012**.

1. I am currently, or have been, **actively enrolled and sponsored** by an ABC chapter, ABC member firm (in-house) or ABC "chapter-approved" training sponsor program **within nine months** prior to the National Craft Championships.
2. I have **not been certified** as a journeyman **more than six months** prior to the date of the National Craft Championships. A journeyman is defined as 1) holding a license from any state, city, county or municipality; or 2) holding a U.S. Department of Labor journeyman's credentials; or 3) being compensated as a journeyman.
3. I possess **no more than six years total experience** in the competition being entered (not including secondary school programs).
4. I did **not compete** within the same competition in any previous ABC National Craft Championships (formerly ABC Craft Olympics).

To verify the extent of work experience, I authorize my current and previous employer(s) to provide any and all work experience information that may be requested by ABC National. I acknowledge that should any of the items above be verified and found to be inaccurate statements, I will be disqualified from the ABC National Craft Championships and any and all winnings I am eligible to receive will be forfeited.
